The original award vests in 3 equal installments on March 23, 2016, February 23, 2017 and February 23, 2018 and convert into shares of common stock on a one-for-one basis unless the executive previously has selected a longer deferral period. Market price at time of grant was \$51.84.
2. The option vests in equal annual installments over a 3-year period commencing February 23, 2016.
